

# Andorra Energy Storage Product Export Rules

How do I export goods from Andorra to Spain?

To export goods from Andorra to Spain, you must include a tax-free commercial invoice and fill in the Single Administrative Document (DUA), which allows you to calculate the applicable tax and will be processed by Spanish customs. Shipments to Spain from Andorra are subject to a 21% tax (corresponding to VAT) calculated in the DUA.

Which countries export the most to Andorra in 2022?

The main destinations for Andorra's exports in 2022 were Spain (78.3%), France (6.2%), United Kingdom (3.2%), Germany (1.5%), and Norway (1.2%), with imports coming chiefly from Spain (66.1%), France (11.5%), Germany (5.0%), China (3.0%), and Italy (2.8% - data Comtrade).

How does customs work in Andorra?

Customs in Andorra, as in all other countries, is responsible for managing goods entering and leaving the territory. This means that people who export must be aware of the taxes, tariffs, procedures and conditions applicable in customs for the transport of goods. Below, we show you how exporting works in Andorra's customs.

How much tax does a ship from Andorra charge?

Shipments to Spain from Andorra are subject to a 21% tax (corresponding to VAT) calculated in the DUA. If an Andorran company provides services to a Spanish company, the Andorran General Indirect Tax (IGI) should not be included in the invoices, as it is a national tax.

How is Andorra regulated?

Andorra's partnership with the European Union is regulated by a commercial treaty, which was signed on 28 June 1990, establishing a Customs Union for industrial products and outlining special provisions for agricultural commodities.

How to import goods from Andorra?

Choose a reliable logistics provider familiar with Andorran imports. Ensure your goods comply with packaging and labeling standards. Collect all necessary documents like invoices, bills of lading, and certificates of origin. Arrange for transportation from the port of entry to your warehouse.
