

Who can import products into Uruguay?

Only commercial firms,industrial firms,or individuals listed in the registry of importers may legally import products into Uruguay. A pro-forma invoice is required to start import procedures, and importers must use an agent to handle the customs clearance process.

### Why are customs procedures important in Uruguay?

Customs procedures in Uruguay play a critical role in the smooth functioning of international trade, facilitating the import and export of goods while ensuring compliance with local laws and regulations.

### Does Uruguay have a quota system?

Uruguay has a liberal import policy. There is no quota system. License is required for the import of products such as medical equipment, chemicals, cattle, sugar, cereals, meat and flour. All importers should nevertheless be registered with the Central Bank and declare all their imports by filling an import declaration.

### Who controls customs in Uruguay?

At a national level,the National Customs Directorate(Dirección Nacional de Aduanas,DNA) applies,collects,and controls taxes under Uruguay's customs code. DNA falls under the Ministry of Economy and Finance; it dictates all customs regulations and controls import and export transactions. For customs-related information or questions,contact:

### How long does import clearance take in Uruguay?

Upon arrival in Uruguay,returning Diplomats will request the Ministry of Foreign Affairs authorization to import household goods. This request will be forwarded to Ministry of Finances for approval and only once approved the import clearance process may be started. Normal customs clearance upon receipt all documents take approx. 12 working days.

#### Does Uruguay have a customs system?

Uruguay applies the harmonized Customs System, based on the World Customs Organization 's system. Customs duties are calculated Ad valorem on the CIF value of the goods. However, Uruguay applies some minimum price for textile and clothing imports. Importers have to pay the difference between the amount of the invoice and the minimum price.

Controlled & Prohibited Goods for Import. Controlled goods require proper authorisation (advance notification, licence or certificate approval) from Competent Authorities (CA) before they may be imported into Singapore. You are advised to check if the goods are controlled using the description of the goods, Harmonized System (HS) code or CA product code via the HS/CA ...
