

Will Turkey impose a tariff on solar panels?

The Turkish government has decided to impose a tariff of \$25 per square meteron solar modules imported from Vietnam, Malaysia, Thailand, Croatia, and Jordan. The Ministry of Trade said last week that it has come up with new provisions for imports of solar panels from Vietnam, Malaysia, Thailand, Croatia, and Jordan.

Which countries will be able to import solar panels?

Is Turkish government dumping solar panels from Asia?

According to Turkish media outlet Hurriyet, the measure is part of an anti-dumping investigation the Turkish government is conducting on solar panel imports from Asia. If the investigation determines that no anti-dumping practices have been implemented in the countries under scrutiny, the tariffs paid by the manufacturer will be returned.

How much does a solar module cost in Turkey?

All other manufacturers present in the five countries and exporting modules to Turkey are applied the \$25/m2 tariff. Their names, however, were not revealed by the Vietnamese authorities. Turkey introduced its first restrictions for solar module imports in April 2020. Its PV cell and module industry has more than 60 manufacturers.

Will the US be able to make Turkish solar panels?
